### Course Description

Commonly referred to as White Card Training, the course relates directly to the general induction training program specified by the National Code of Practice for Induction Training for Construction Work (ASCC 2006). This course covers the general WHS induction information you require to work on a construction site in Australia.

This course requires the learner to demonstrate personal awareness and knowledge of health and safety legislative requirements in order to work safely and prevent injury or harm to self and others. It covers identifying and orally reporting common construction hazards, understanding basic risk control measures, and identifying procedures for responding to potential incidents

and emergencies. It also covers correctly selecting and fitting common personal protective equipment (PPE) used for construction work.

This course is a prerequisite for obtaining a White Card. A White Card is mandatory for anyone who works or wants to work in the construction industry.

### Course Outcomes

You will learn about:

- Work Health and Safety responsibilities.
- Identifying and managing construction hazards and risks.
- Responding to accidents and incidents.

Upon successful completion of this course, the learner will receive a Statement of Attainment. After successful completion of this course it is the responsibility of the participant to apply for their White Card through Access Canberra.

### Course Assessments

Competency is obtained through both theory and practical assessments. The practical assessment requires you to demonstrate the skills required to

be deemed competent. The theory assessment will be undertaken in a written form. If you feel you will be disadvantaged by undertaking a written assessment, please discuss with your trainer/assessor prior to beginning the theory assessment.

### Admission

All attendees must have a USI (Unique Student Identifier). We are unable to issue a credential unless a valid USI has been provided.

You will need to apply for a USI prior to the course or be prepared to apply for one on the day (in which case a Driving License and Medicare Card is required).

### Attendance

The course will be delivered from our training centre at 31 Whyalla Street, Fishwick ACT. Safenet can also deliver this course in-house by request.

The duration for this course is 8 hours.

There is a 15 minute break for morning or afternoon tea and a 30 minute break for lunch (light lunch is included in the cost).
